How to appeal against the decision of the Swedish Ethical Review Authority

Who may appeal?

It is the research entity that may appeal against the decision of the Swedish Ethical Review Authority if it has gone against the applicant. The appeal must be in writing. The letter must be signed by an authorised representative of the research entity.

If the investigator appeals, a power of attorney from the research entity must be attached.

When must the appeal be lodged at the latest?

The appeal must have been received by the Administrative Court within three weeks from the date when the appellant was informed of the ruling.

What must the appeal contain?

The appeal must contain information on

- the appellant's name, personal or corporate identity number, address, telephone number and e-mail address
- 2. the decision appealed against (date of decision, project title and reference number)
- 3. how you consider that the board's decision must be amended and the reasons why the decision should be amended.

Where must the appeal be sent?

The appeal is to be submitted to the Ethics Review Appeals Board. However, it is to be sent or handed over to the Swedish Ethical Review Authority.

If the appeal has been received in good time, the Swedish Ethical Review Authority will hand over the appeal and the documents to the Ethics Review Appeals Board.
